- Opportunities to influence environmental and planning law and policy.

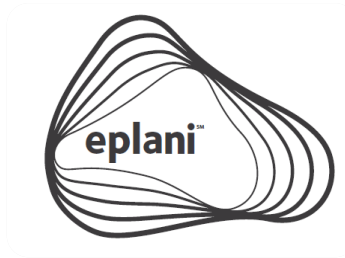

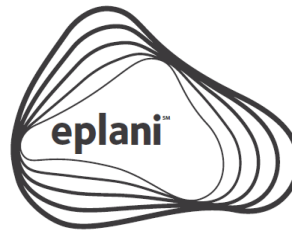
