With reference to the above please note that renewal subscriptions are now due for EPLANI.

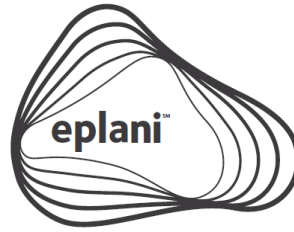
